## **2.6 Evolving Strategies to meet the target:**

Since the Affiliating University is trying to implement NEP 2020 from the coming Asacemid Session, the College is trying its best to cope with the expected courses to be implemented. For this, MoU had been already signed with Vocational School of Education, Chaltlang and NIELIT to give instruction in Vocational Studies/Skill Development Courses. The College is also trying its level best to create more classroom which will be ICT enable and also smart classrooms as more class rooms will be required with the implementation of NEP 2020.

The College will try to open New Departments and New Streams in due course to increase enrollment as envisaged by NEP 2020. With that, the college can be transformed into Multi-disciplinary Institution from Single Stream institution.

Later the College will take steps to open PG Departments and will try to have new Campus which can accommodate large number of students as envisaged by NEP 2020.

## **2.7 Propose Governance Structures and Processes:**

Being a Government College, Affiliated to University, the Institution will be under the rules and guidelines of the Affiliating University in Academic matters and under the instruction of the Secretariat and Directorate of Higher & Technical Education Department in matters pertaining to administration until it can become autonomous.

At present, the Principal is the head of the Institution, assisted by the Vice Principal and Head of Departments in Academic matters. In matters concerning to administration, he is assisted by all the Non-Teaching Staffs. As envisaged by NEP 2020, the Institution will move forward for attaining autonomy. If it can attain autonomy status, administration, policy making, etc. will be taken up by the Governing Board, The Academic Council, Board of Studies, Finance Committee, Planning Board, etc.



## **2.8 Academic Programme:**

The College is a co-educational institution with single stream i.e. Arts. There are 7 departments in the College. The Institution follows the curriculum designed and planned by the affiliating University i.e. Mizoram University. The Choice Based Credit System course has been successfully implemented in the UG Programmes since 2016. As the University is planning to implement NEP 2020 from the Academic Session 2023-2024, the College is preparing itself by constituting Task Force Committee for implementation of NEP 2020 which will focus on implementation of Multiple Entry and Exit with the aim of removing rigid boundaries and create new possibilities for students to choose subjects of their choice. This will pave the way for students to have seamless mobility within or across the country through formal system of credit recognition and transfer. In ensuring a holistic and multi- disciplinary education, the course structure will be imaginative and flexible in nature with creative combination of credit-based courses.

## **2.9 Human Resource management:**

The Principal is the head of all administrative set up in the College. He is assisted by the Vice Principal who is appointed internally by the Principal. In the Academic sphere, the Principal is assisted by the Vice Principal and Head of Departments and in administration, by all the Non-Teaching staffs under the Head Assistant. There are different Cells/Committees under IQAC which looked after different activities in the College. All the Cells are under the supervision of the Principal and IQAC Coordinators.

## **2.10 Student Support System:**

- \* Certificate and cash awards are given to University rank holders.
- \* Provide Career Guidance to the students.
- \* Provide Remedial Classes to weaker students.
- \* Provide add-on course such as CCC and Office Assistant.
- \* Mentoring system is carried out where individual teacher in assigned students.
- \* Students are given work in their spare time to earn if they desire.

## **2.11 Financial Plan:**

Being a Government Institution, the College does not have financial autonomy. However, available funds are utilized for development of the College and for student's welfare.

## 2.12 **Process of Implementation, Monitoring and Evaluation.**

As per instruction from the Directorate of Higher & Technical Education Department, Govt. of Mizoram, institutional Task Force on NEP 2020 has been constituted. This Committee is expected to oversee the implementation, monitoring and evaluation of the vision and objectives of the institution in view of NEP 2020. The College had already organized “**One Day Orientation Cum Awareness Programme**” and “**One Day Sensitization Programme**” on NEP 2020 for all faculty members. Faculty members from various Committees also attended a Symposium on Implementation of NEP 2020, jointly organized by Planning & Programme Implementation Department and Directorate of Higher & Technical Education Department, GoM.
