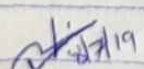

Resolution : - Date of Visit to Adopted School - 29.07.19.

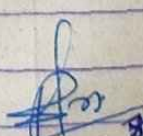
- The first batch of Core Students to visit the adopted school are English Core and Mizo Core. Five (5) students each from the two departments to be selected.

The committee expressed their problem with financial assistance for which the principal advised to apply to the principal.

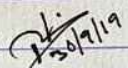

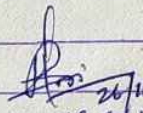
AGENDA : Preview of AAR 2018-2019.

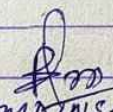
② The committee unanimously approved the mentor-mentee proposal prepared by the Co-Ordinators.
